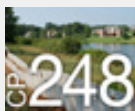

- Prepare a Storm Water Pollution Prevention Plan (SWPPP) for construction activities.

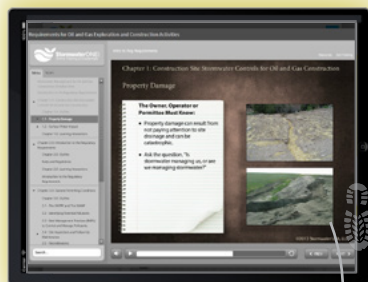

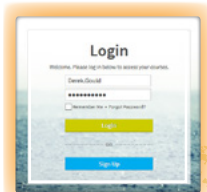

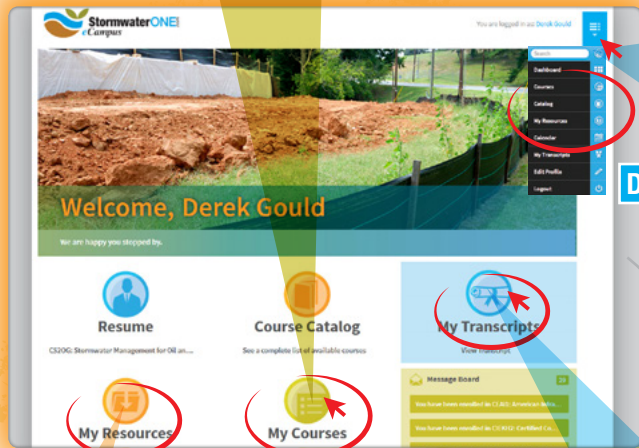
