- Understand the teamwork and communication necessary between owner, operators, contractors and SWPPP designer so the site stays in compliance throughout the construction project.

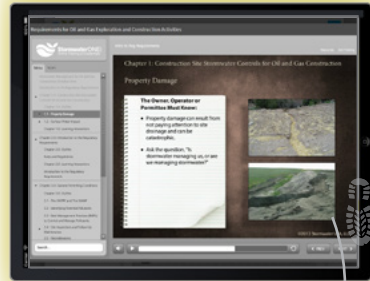

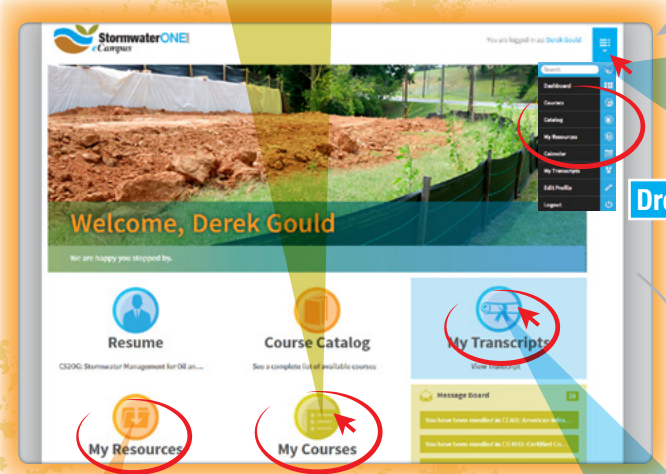
