2020 CPSI Course Registration

Blended Learning Course Information

In order to prioritize their health and safety, NRPA will not be permitting CPSI instructors to travel and thus has cancelled in-person courses for the foreseeable future. Instead, they have released a plan for a blended learning version of the CPSI course which will be provided as a **virtual training**. The CPSI Blended Learning Course is comprised of two steps: the completion of the **CPSI Online Prep Course** followed by a **Live Virtual Course** led by a CPSI Instructor.

CPSI ONLINE PREP COURSE:

- Following registration, course participants will receive an email with information on how to access the course
- The course is self-paced, approximately 12 hours in length, and must be completed 24 hours prior to the Live Virtual Course.

LIVE VIRTUAL COURSE:

- One-day, 4-hour virtual training course done via Zoom and be led by a CPSI Instructor.
- Participants have the **choice of one** of the four following dates: **Jul 28, Jul 29, Oct 6, or Oct 7 - 8:00 am -12:00 pm EST**
- There is a limit of 20 participants per date. Seats for the Live Virtual Course will be allotted on a first-come, first-served basis

CPSI EXAM

- Participants that are registered for the CPSI exam will now be taking the exam at a local computer testing center.

- Participants will receive an email with information on scheduling the exam approximately one week prior to the Live Virtual Course.

IMPORTANT NOTES:

- **COURSE-ONLY REGISTRANTS** will still only participate in the ONLINE PREP and LIVE VIRTUAL COURSES. You will not sign up for the exam.
- **EXAM-ONLY REGISTRANTS** will still only be taking the exam. You will not receive course materials or information on accessing the online course.
- Participants must complete **BOTH** the CPSI Online Learning course and the CPSI Virtual Learning Session to receive CEUs.
- Once a participant has started the online learning course and/or opened the wrapping on their books, no refunds will be issued for course.

TIMEFRAME:

- Course participants have **180 days** from registration date to access and complete the 12-hour online course – **Must complete this online course no later than 24 hours before the CPSI Virtual Learning Session**
- Course participants must complete the **4-hour Zoom** instructional meeting
- Course participants will have **83 days** following the zoom meeting to take the computer based exam.

General Information

Class Size: A minimum of 20 participants is required to run the class. There are 4 date options for the Live Virtual Course, making the maximum possible number of total registrants 80. Registration is on a first-paid, first-served basis. No walk-ins will be allowed for the course or the exam. Notification of class cancellation, if needed, will be two weeks prior to the start of the course.

CEU Credits: **1.5 CEU Credits** (*CEU fee is included in registration fee*)

Pre-Course Study Materials: Attendees registered for the course will receive course study materials. Individuals registering for the **exam only** will not receive these materials. You will receive the course study materials approximately three weeks before the course. NRPA does not recommend that you attempt to take the exam unless you have access to the materials three weeks prior to the course. If you register less than three weeks before the course date, you will need to pick up your study materials at the CRPA office or make other arrangements.
